Chairman's Comments:	Chairman Barr called the meeting to order. Deputy Director		
	Veal determined that a quorum was present and announced

	Mr. Langdale's motion to adopt the open meeting minutes from

Director's Report:	Deputy Director Veal informed the Panel that the JQC's budget is on track so far for FY23.	
	Deputy Director Veal inquired of the Panel whether they still wished to hold our June meeting in Savannah, which would coincide with the State Bar of Georgia's Annual Meeting. The Panel discussed logistics and budgetary considerations and decided to hold the June meeting in Atlanta on the regularly scheduled date of June 16, 2023.	
	Deputy Director Veal informed the Panel that the complaint log for 2022 is available on Box for review. There were 1,101 complaints filed in 2022. Chairman Barr inquired of the status of the Annual Report. Deputy Director Veal stated that the Staff is working on it and will distribute a draft once completed. The 2023 complaint log is also on Box for review.	
	Mr. Langdale updated the Panel on the recent Senate Sub- Committee Meeting involving the JQC's Amended Budget for FY23 and made suggestions regarding how the Staff may better track the budget moving forward.	
	Judge Darrisaw informed the Panel that Deputy Director Veal recently presented at the Superior Court Judges Conference and received a great amount of positive feedback.
